

# Key2SafeDriving™ Activator's One (1) Year Limited Warranty

Safe Driving Systems' warranty obligations for this hardware product are limited to the terms set forth below:

Safe Driving Systems, LLC. ("SDS") warrants this Key2SafeDriving-branded hardware product against defects in materials and workmanship under normal use for a period of ONE (1) YEAR from the date of retail purchase by the original end-user purchaser ("Warranty Period"). If a hardware defect arises and a valid claim is received within the Warranty Period, at its option and to the extent permitted by law, SDS will either (1) repair the hardware defect at no charge, using new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product. SDS may request that you replace defective parts with new or refurbished user-installable parts that SDS provides in fulfillment of its warranty obligation. A replacement product or part, including a user-installable part that has been installed in accordance with instructions provided by SDS, assumes the remaining warranty of the original product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes SDS's property. Parts provided by SDS in fulfillment of its warranty obligation must be used in products for which warranty service is claimed. When a refund is given, the product for which the refund is provided must be returned to SDS and becomes SDS's property.

## EXCLUSIONS AND LIMITATIONS

This Limited Warranty applies only to hardware products manufactured by or for SDS that can be identified by the "SDS" trademark, trade name, or logo affixed to them. The Limited Warranty does not apply to any non-SDS hardware products or any software, even if packaged or sold with SDS hardware. Manufacturers, suppliers, or publishers, other than SDS, may provide their own warranties to the end user purchaser, but SDS, in so far as permitted by law, provides their products "as is". Software distributed by SDS with or without the SDS brand name (including, but not limited to mobile phone software) is not covered under this Limited Warranty. Refer to the licensing agreement accompanying the software for details of your rights with respect to its use.

SDS does not warrant that the operation of the product will be uninterrupted or error-free. SDS is not responsible for damage arising from failure to follow instructions relating to the product's use.

## OBTAINING WARRANTY SERVICE
